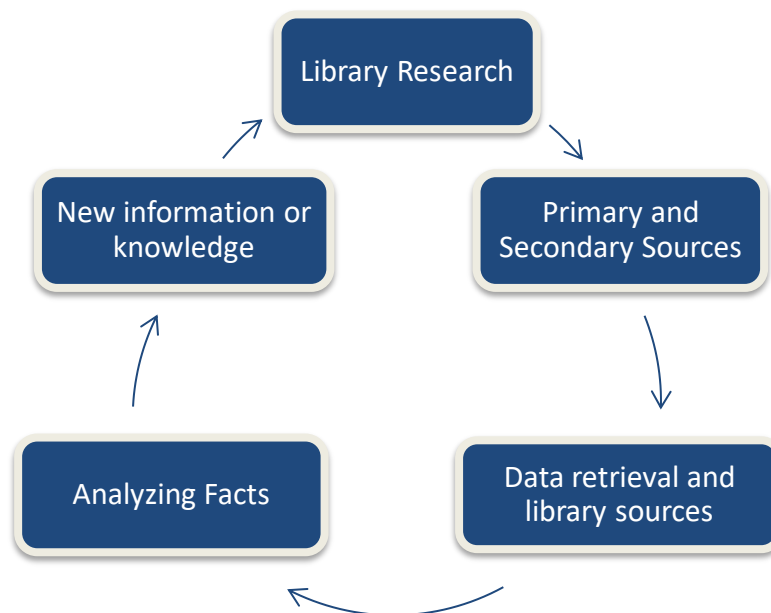


Figure 1. Library Research Process
